Dear Mr. President and Mr. Governors:

The following is the report on the status of the 2007 Single Audit for FSM as of March 31, 2007 based on information received from Deloitte & Touche (DT).

YAP STATE

- 1. Yap State Government: No change in the status has occurred on this audit since the last report. A consultant/accountant has been sent to assist in the closing process.
- 2. Diving Seagull Inc: Fieldwork has been completed and the file is being finalized.
- 3. Yap Visitor's Bureau: DT has obtained requested preliminary information and is scheduling fieldwork.

POHNPEI STATE

- 1. --- Pohnpei State Government- The audit is approximately 75% complete.
- 2. Pohnpei Fisheries Corporation: The audit has been drafted and is going through the closing process.
- Pohnpei Housing Authority The audit is approximately 65% completed. Major open items are bank reconciliations, loan documents, attorney replies, MD&A and subsequent events procedures.
- 4. Pohnpei Utilities Corporation The audit is approximately 40% complete.

FSM NATIONAL GOVERNMENT

- 1. National Government: The audit is approximately 72% completed. There are still several schedules and inquiries pending to be submitted.
- 2. FSM Development Bank Fieldwork has been substantially completed and the file is being finalized.
- 3. National Fisheries Corporation The audit is 60% complete.

- 4. COM-FSM: This audit has been drafted and is going through the closing process pending return of the Comptroller.
- 5. MiCare: The audit should be released this week.
- 6. FSM Coconut Development Authority: The audit has been drafted and is going through the closing process.
- 7. FSM Social Security Administration This audit has been drafted and is going through the closing process.

KOSRAE STATE

- 1. Kosrae State Government: The audit is approximately 80% complete. There are still several schedules and inquiries pending to be submitted.
- 2. KUA- Field work has been completed and the file is being finalized.
- 3. MPC- Field work has been completed and the file is being finalized.

CHUUK STATE

- 1. Chuuk State Government- DT is awaiting word as to the closing of the books and will then commence fieldwork.
- 2. Chuuk Health Care Plan DT has submitted the preliminary requests and will then commence fieldwork.
- 3. Chuuk Housing Authority DT is awaiting word as t the closing of the books and will then commence fieldwork.
- 4. Chuuk Public Utility Corporation- DT has submitted the preliminary requests and upon CPUC's receipt, DT will then commence fieldwork.

- 2. Yap State Public Services Corporation
- 3. Pohnpei Port Authority
