Dear Mr. President and Mr. Governors:

The following is the report on the status of the 2009 Single Audit for FSM as of March 31, 2010 based on information received from Deloitte & Touche (DT) and Fortenberry & Ballard (FB).

FSM NATIONAL GOVERNMENT

- FSM National Government: Audit testing and procedures are ongoing for both compliance and financial sections. 80% of the compliance and financial testing is completed. DT has provided the initial preliminary findings to the Assistant Secretary of National Treasury on April 7, 2010.
- National Fisheries Corporation: We have provided a draft report to NFC for their review.
- College of Micronesia-FSM: DT has commenced compliance testing and is approximately 85% completed with such. DT has received the trial balance and most of the related schedules. Fieldwork is approximately 70% complete.
- 4. MiCare Plan, Inc.: Final audit reports were issued on March 09, 2010.
- 5. FSM Coconut Development Authority: Fieldwork is approximately 60% complete. DT is waiting for inventory related documents.
- 6. FSM Development Bank: DT has commenced year-end audit procedures. Fieldwork is about 75% complete.

- 7. FSM Social Security Administration: Fieldwork is about 99% complete. DT is in the process of finalizing the draft report.
- 8. FSM Petroleum Corporation: DT has received the trial balance February 11, 2010 and commenced fieldwork testing.
- FSM Telecommunications Corporation: Final audit reports were issued on December 11, 2009.

CHUUK STATE GOVERNMENT

- 1. Chuuk State Government: DT has completed approximately 95% of fieldwork.
- Chuuk Health Care Plan: DT has received the trial balance as of September 30, 2009 and is in the process of planning the audit.
- 3. Chuuk Housing Authority: DT has received the trial balance as of September 30, 2009 and is in the process of planning the audit.
- Chuuk Public Utility Corporation: DT has received the trial balance and some of the related schedules. Fieldwork is anticipated to commence on April 14, 2010.

KOSRAE STATE GOVERNMENT

- 1. Kosrae State Government: DT has completed approximately 95% of fieldwork.
- Kosrae Utilities Authority: DT has received the trial balance and most of the supporting schedules and commenced fieldwork. Fieldwork is about 70% complete.
- Kosrae Port Authority: KPA is in the process of revising the final trial balance.
 Commencement of fieldwork is pending the receipt of final trial balance and supporting schedules.

POHNPEI STATE GOVERNMENT

- 1. Pohnpei State Government: DT has completed approximately 95% of fieldwork.
- Pohnpei Fisheries Corporation: Pohnpei State Finance is in the process of putting PFC financial statements on its books. DT will commence the audit upon receipt of the trial balance and related schedules.
- 3. Pohnpei Utilities Corporation: Fieldwork has been substantially completed and DT is in the process of drafting the audit report.
- Pohnpei Port Authority: DT has commenced the year-end audit procedures.
 Fieldwork is about 90% complete.

YAP STATE GOVERNMENT

- Yap State Government: The audit of Yap State is 90% complete. Yap State's
 fieldwork is complete. The audit report is in progress. Completion of the
 engagement also awaits receipt of several component unit financial statements
 from the Yap Public Auditor. A formal exit conference with the Governor and the
 possible resolution of a few 2008 and 2009 audit findings are in progress.
- Yap State Public Service Corporation: The final audit report was issued on December 31, 2009.
- 3. Yap Diving Seagull, Inc.: The final audit report was issued on January 15, 2010.
- 4. Yap Visitors' Bureau: The final audit report was issued on February 01, 2010.
