Dear Mr. President and Mr. Governors:

This is the sixth status report for the FY 2012 Single Audits and it is as of May 30, 2013. We will continue to send you status reports every month until all the Single Audits for FY 2012 are completed. The status reports are based on information received from Deloitte & Touche (DT), our contracted CPA firm. The official completion deadline is June 30, 2013.

FSM NATIONAL GOVERNMENT AND COMPONENT UNITS:

- 1. <u>FSM National Government:</u> DT is approximately 85% complete with fieldwork and have started the process of preparing the draft audit report.
- College of Micronesia-FSM: DT is complete with the audit fieldwork and a draft audit report was provided to COM-FSM on May 22 for their review and comments.
- 3. <u>FSM Telecommunications Corporation:</u> Final audit report completed. A copy of the report can be accessed at the ONPA website <u>www.fsmopa.fm</u>.
- FSM Petroleum Corporation: DT has substantially completed fieldwork for both Vital and FSMPC and are in the process of drafting the audit reports.
- 5. <u>National Fisheries Corporation:</u> Final audit reports are expected to be complete in the month of June 2013.
- 6. MiCare Plan, Inc.: DT has completed the audit fieldwork and draft copies were provided to MiCare for their review and comments.
- 7. <u>FSM Coconut Development Authority:</u> DT has completed the audit fieldwork and are in the process of preparing the draft audit reports.

- 10. <u>Caroline Islands Air:</u> There is no change from previous status report. DT is approximately 90% complete with fieldwork. A draft audit report has been provided to CIA for the preparation of their MD&A.

- 1. <u>Chuuk State Government:</u> A draft audit report was provided to Chuuk State Government on May 31, 2013 for their review and comments.

- 3. <u>Chuuk State Health Care Plan:</u> A draft audit report was provided to Chuuk State Health Care Plan on May 23, 2013 for their review and comments.
- 4. <u>Chuuk Housing Authority:</u> DT has completed fieldwork and has included the financial statements in the Chuuk State Government draft audit report.

- Pohnpei State Government: A draft audit report has been provided to Pohnpei State Government for their review and comments.
- Pohnpei State Housing Authority: DT has completed the audit fieldwork and are in the process of preparing the draft audit reports.
- Pohnpei Utilities Corporation: Final audit reports are expected to be complete in the month of June 2013.
- Pohnpei Port Authority: Draft audit reports were provided to PPA on May 31, 2013 for their review and comments.

- Kosrae State Government: A draft audit report was provided to Kosrae State Government for their review and comments on May 28, 2013.
